



**2019 Big Tires and Campfires  
Raffle Terms & Conditions  
Conducted by Idaho Aviation Foundation**

**GENERAL**

- Raffle proceeds to benefit:
  - the Idaho Aviation Foundation's ("IAF") efforts to rebuild historic Big Creek Lodge, and
  - other charitable or government organizations related to aviation in Idaho, at the discretion of the IAF.
- To be eligible, participants must be 18 years or older and agree to abide by the terms and conditions listed herein.
- Tickets will be sold for \$20 each.
- A maximum of 1,000 tickets will be sold. Unsold tickets will be withdrawn from the drawing.
- All tickets sold have an equal chance to win.
- Drawing will be held on June 15, 2019, no earlier than 10 a.m., at Big Creek Lodge - Big Creek Forest Service Airstrip, Edwardsburg, Idaho (the "Big Raffle"). In case of rain or significant weather, the drawing will be held on Sunday, June 16, 2019.
- Winner need not be present to win the Main Prize and Other Prizes having an estimated value of more than \$500.
- Winners must be present to win all Other Prizes having an estimated value of \$500 or less.

**PRIZES**

- The Main Prize is a certificate for a pair of tires from Airframes Alaska, either Ultralights, Airstreaks, or Bushwheels up to 31" (but excluding 35"). Shipping within the U.S. is included. - Prizes, other than the Main Prize ("Other Prizes"), are items selected by the IAF. A list of Other Prizes will be available at the Big Raffle.

**DRAWING**

- Winner will be selected by random drawing. If a Winner forfeits any Prize (see Winner Details below), a second name will be randomly drawn, and so forth until a Winner accepts the Prize under the terms listed below.
- Winning tickets drawn for Other Prizes will be excluded from subsequent drawings for Other Prizes.
- All winning tickets will be readmitted to the drawing pool for the Main Prize drawing, to be held last.

**WINNER DETAILS**

- If multiple names are on the winning ticket, only the first name listed will be considered the Winner.
- Winner of the Main Prize will be provided a prize certificate either in person or by Certified US Mail. Winner will be assumed to have accepted the prize unless the Winner declines the Main Prize in writing to IAF within 3 business days after the date the certificate was received.
- Winner of the Main Prize or Other Prize certificates shall have no rights in or to that prize until Winner redeems the certificate at the prize certificate sponsor. Until that time, the prize remains sole property of the prize certificate sponsor.

- If a Winner does not accept the Main Prize or the Other Prize drawn at the Big Raffle, that prize is forfeited and no substitute prize will be provided to that person.
- Installation of any prize will be the responsibility of the Winner.
- Winner of any Other Prize must accept the Other Prize or its certificate at the Big Raffle.
- Acceptance of any Prize constitutes permission for IAF and Airframes Alaska to use the winner's name, picture, video image, relevant quotes to promote Airframes Alaska, the Idaho Aviation Foundation, and/or the Big Creek Lodge.

### **NO WARRANTY**

- Winner accepts any prize AS-IS and without recourse to the IAF, Airframes Alaska, or any other sponsor with respect to any defect, damage, injury or other problem that may arise with respect to the prize.
- Ticket purchasers acknowledge that the maximum liability of the IAF, if any, is the cost of the ticket.

### **INELIGIBLE PARTIES**

- Ineligible parties include members of the Board of Directors of the Idaho Aviation Foundation, and employees, managers, directors, or owners of Airframes Alaska, including immediate family members of any of these organizations (defined as spouse, parents, brothers, sisters, children, grand-children, and 'step' and adoptive relationships)

### **TICKETS**

- A ticket represents a chance to win the opportunity to accept the specific prize presented in the drawing at the Big Raffle. A ticket is the official raffle entry that includes entry contact information which is provided by the entrant for the actual drawing.
- All sales of tickets are final, and no refunds will be paid.
- A ticket that was issued in exchange for a check returned for 'insufficient funds' or for a credit card that was 'declined' or invalid, stolen, or voided cannot be a winning ticket.

### **TAXES & OTHER COSTS**

- The Idaho Aviation Foundation is a charitable non-profit 501(C)(3) organization.
- The IRS has ruled that a payment for a raffle ticket of this nature is a tax-deductible charitable contribution to the fullest extent of the law. In other words, the winner of the prize would not be eligible for a tax deduction, but non-winners would likely be able to do so. Consult your tax accountant.
- Each winner is solely responsible for payment of all federal, state and/or local income, sales or use taxes due to his or her acceptance of any prize.
- The value of a prize may be included in the winner's gross income and may be subject to reporting by the IAF to the IRS.
